

HUNTLY – HOST ONBOARDING FORM

Getting started with Huntly is straightforward and rewarding. By following a few easy steps, you can list your farm, showcase your hunting experience, and begin welcoming guests who are eager to explore what you offer.

TERMS AND CONDITIONS

Please read carefully before completing this form. By submitting the Huntly Host Onboarding Form, you confirm that you have read, understood, and agreed to the following terms and policies. Your submission constitutes legal consent to participate as a listed host on the Huntly platform.

1. Agreement to Participate

By completing and submitting this onboarding form, the farm/outfitter (“Host”) agrees to be listed on the Huntly platform and consents to Huntly’s terms of service, privacy policy, and operational guidelines.

2. Accuracy of Information

The Host guarantees that all information provided in this form is accurate, complete, and truthful. Any changes to farm details, pricing, availability, or legal documentation must be communicated to Huntly in writing within 7 days.

3. Legal Compliance

The Host agrees to operate in full compliance with all applicable South African laws and regulations, including but not limited to:

- Hunting permits and quotas
- Land use and conservation laws
- Firearm and safety regulations
- Tourism and accommodation licensing

The Host is responsible for maintaining valid documentation and ensuring all hunting activities are legally sanctioned.

4. Animal Welfare & Ethical Hunting

The Host commits to ethical hunting practices and humane treatment of all animals. The hunting of endangered, exotic, or protected species (e.g., lions, leopards, cheetahs, crocodiles, pangolins) is strictly prohibited. All hunts must be conducted in accordance with fair chase principles.

5. Guest Safety & Liability

The Host is solely responsible for the safety and well-being of guests while on the property. This includes:

- Providing safe accommodation and facilities

- Ensuring qualified guides and staff are present
- Maintaining equipment and vehicles in working condition

Huntly is not liable for any injuries, accidents, losses, or damages incurred during hunting activities or farm stays.

6. Booking & Cancellation Policies

The Host must honour the booking terms, daily rates, and cancellation policies listed in Section 5 of this form. Any changes must be submitted in writing and approved by Huntly before taking effect.

7. Combo Package Restrictions

If offering a Combo Package, the Host agrees to:

- Limit hunts to **one hunter per package**
- Include **no more than four species per hunt**
- Clearly define pricing and available dates
- Ensure all species listed are legally huntable and sustainably managed

8. Pricing Transparency

All prices listed must be inclusive of applicable taxes and fees. Hidden charges or unlisted costs are not permitted. Hosts must provide clear breakdowns of what is included in the daily rate and package pricing.

9. Media Usage & Consent

By submitting photos, logos, and farm descriptions, the Host grants Huntly a non-exclusive, royalty-free license to use this content for:

- Marketing and promotional campaigns
- Social media and digital advertising
- Website and mobile app listings

The Host confirms that all submitted media is owned or properly licensed and does not infringe on third-party rights.

10. Banking & Payouts

The Host agrees to provide accurate banking details for payouts. Huntly will process payments according to its standard payout schedule. The Host is responsible for any banking fees, currency conversion charges, or tax obligations.

11. Conduct & Reputation

The Host agrees to maintain a professional and respectful environment for all guests. Huntly reserves the right to suspend or remove listings that:

- Receive consistent negative feedback

- Violate ethical or legal standards
- Misrepresent services or pricing
- Endanger guests or wildlife

12. Data Protection & Privacy

Huntly will handle Host data in accordance with its Privacy Policy. Hosts must also respect the privacy of guests and refrain from sharing personal information without consent.

13. Termination of Agreement

Huntly may terminate this agreement and remove a listing at any time for breach of terms, legal violations, or reputational risk. Hosts may also request removal of their listing with 30 days' written notice.

14. Acknowledgment & Consent

By completing and submitting this form, the Host confirms:

- They have read and understood these Terms and Conditions
- They agree to abide by all listed policies and responsibilities
- They consent to being listed on the Huntly platform
